

Win a Drone - TeamViewer Pilot Viral Video Contest

TERMS AND CONDITIONS & OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN

- **1. ELIGIBILITY**: The Win a Drone TeamViewer Pilot Viral Video Contest is open only to legal residents of the fifty (50) United States, the District of Columbia or Canada who are eighteen (18) years of age or older. TeamViewer employees as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to enter. The Contest is subject to federal, state, and local laws and regulations and is void where prohibited.
- **2. SPONSOR:** The Contest is sponsored by TeamViewer US, Inc.
- **3. AGREEMENT TO OFFICIAL RULES:** Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- **4. ENTRY PERIOD:** The Contest begins Jan. 7, 2020 (the "Entry Period") and ends on Jan. 31, 2020. Entries that are submitted before or after the Entry Period will be disqualified.
- **5. CREATE AND SUBMIT AN ENTRY:** Use the free TeamViewer Pilot app on your mobile device to create a video tutorial, then upload the video tutorial to YouTube using the hashtag #MYPILOTVIDEO. Eligible Entries will be judged to determine the prize winner. Note that any personal information associated with your YouTube profile is collected by the sponsor of this contest, for the purposes of this contest. In entering the contest and agreeing to these terms and conditions, you are granting consent for the collection of this information. Your personal information will not be shared with any third parties.
- **7. ENTRANT'S WARRANTIES AND REPRESENTATIONS:** By submitting an Entry, each entrant warrants and represents that the Entry (a) is original to the entrant, (b) does not infringe the intellectual property, privacy, publicity, or any other rights of any third party, and (c) does not violate any law or regulation.

- **8. SPONSOR'S RIGHTS TO ENTRIES:** By submitting an Entry, you agree not to instigate, support, maintain, or authorize any action, claim, or lawsuit against the Sponsor on the grounds that any use of the Entry infringes any of the entrant's rights as creator of the Entry, including, without limitation, copyrights, trademark rights, and moral rights.
- **9. SELECTION OF WINNER:** On or about 2/28/2020 at 12PM EDT, the top three video submissions will be selected. The three (3) Entries with the highest aggregate comments, shares, likes, and views will be selected to receive one prize each. Likes, comments, shares, and views are weighted equally; spam comments or multiple comments/views by the same user (or by the contestant) will not be counted.
- 10. PRIZES: One (1) Grand Prize Winner will receive one (1) DJI Mavic drone. One (1) Second place runner-up will receive one (1) pair of Apple Airpods Pro. One (1) Third place winner will receive one (1) Oculus Go 32 GB virtual reality headset. Prizes are not transferable or refundable and must be accepted as awarded. No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute a prize (or component thereof) with another prize (or component thereof) of equal or greater value if the prize is not available for any reason as determined by the Sponsor in its sole discretion. Sponsor will contact Prize winners and collect the necessary contact information for shipment of prize. Contest winners are responsible for any and all other costs and expenses not listed above. Prizes may be reported as income and each winner will be responsible for all taxes associated with the receipt of a prize.
- **11. PRIVACY AND PUBLICITY:** Except where prohibited, participation in the Contest constitutes an entrant's consent to the Sponsor's use of the Video created with the purpose of entering this contest, including for promotional purposes, in any media, without further payment or consideration.
- **12. GENERAL CONDITIONS:** In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) award the prizes at random from among the eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official

Rules or in an offensive, inappropriate, or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to any online entry, the authorized account holder of the YouTube account used to enter will be deemed to be the participant.

- 13. RELEASE AND LIMITATIONS OF LIABILITY: By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and their respective officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Contest or receipt or use of any prize, including, but not limited to: (a) any technical errors that may prevent an entrant from submitting an entry; (b) unauthorized human intervention in the Contest; (c) errors in the administration of the Contest or the processing of entries; or (d) injury, death, or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering, if any, and participating in the Contest, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.
- **14. DISPUTES:** Except where prohibited, entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Florida. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of Florida, without giving effect to any choice of law or conflict of law rules (whether of the State of Florida or any other jurisdiction), which

would cause the application of the laws of any jurisdiction other than the State of Florida.
